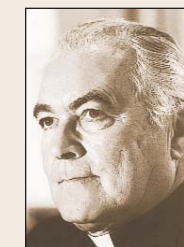
### HONORING RESEARCH AND LEADERSHIP EXCELLENCE

The TIAA-CREF Institute administers two awards that recognize and honor important contributions to the well-being of individuals and institutions in the higher education community.



The TIAA-CREF **Paul A. Samuelson Award** is named in honor of MIT Professor of Economics, Emeritus, Nobel Laureate and former CREF trustee.

It is awarded annually in recognition of an outstanding research publication containing ideas that the public and private sectors can use to maintain and improve America's lifelong financial well being.



The TIAA-CREF **Theodore M. Hesburgh Award** is named in honor of the president emeritus of the University of Notre Dame and former member of the TIAA-CREF Board of Overseers.

The award recognizes leadership and commitment to higher education and contributions to the greater good. It is presented to a current college or university president or chancellor at the American Council on Education annual meeting.
